THIS COMPLETED DECLARATION MUST BE HANDED IN on the day at the registration desk

The entry of the above boat is conditioned on acceptance of the following by the Owner /Competitor racing the boat:

1. The race organizers (including Newhaven & Seaford Sailing Club) shall not be liable for any loss, damage, death or personal injury howsoever caused to the Owner/Competitor, his helm or crew as a result of their taking part in the race. Moreover, every Owner/Competitor warrants the suitability of his boat for the race or races.
2. The provision of safety equipment and boats by Newhaven & Seaford Sailing Club is neither guarantee that assistance can be rendered to any Competitor in need, nor an acceptance of any responsibility for rescue of competitors. Further, in the event that assistance is rendered to any Competitor, no liability for any loss, damage or injury to the Competitor and/or the boat and its equipment is accepted by either the Club or the crew of such safety craft.
3. RRS Fundamental Rule 4: A boat is solely responsible for deciding whether or not to start or continue racing.
4. I agree to be bound by the Racing Rules of Sailing and by all other rules that govern this event.
5. I declare that I hold a valid certificate of insurance which also covers me whilst racing (including Third Party liability cover of at least £3million) and which will be valid for the duration of the event.
6. NSSC implements the RYA racing charter and competitors are required to undertake to sail in compliance with the charter.
7. Competitors are to wear buoyancy aids when racing. Wet suits and dry suits do not constitute personal buoyancy
8. I understand that if the boat is in the charge of any person other than the undersigned, it is the responsibility of the undersigned to bring the attention of the person in the charge of the boat to the provisions of this entry form

Dependents Declaration if competitor is under 18 years old

Under law this helm is my dependent and I accept the following which excludes my dependent's right to claim compensation in certain circumstances:

1. The safety of a boat and her entire management including insurance, shall be the sole responsibility of the owner/person in charge, who must also ensure that the boat and crew are adequate to face the conditions that may arise in the course of a race.
2. Neither these sailing Instructions nor any inspection of the boat limits or reduces the absolute responsibility of the owner/person in charge for the crew, the boat and her management.
3. The race organizers shall not be responsible for any loss, damage, death or personal injury howsoever caused to the owner/person in charge or crew, as a result of their taking part in the race or races
4. Moreover, every owner/person in charge warrants the suitability of the boat for the race or races
5. I declare that during the event the boat will have third party insurance of at least £3million. I confirm that my dependent is competent to take part and that I am responsible for my dependent throughout the event. I will remain on-site or I will inform the Race Committee in writing who will be acting in loco-parentis.
